

<p>bind</p> <p>definition (at least 3) At least one from a book. If you use an online dictionary, choose 2 different ones for your definitions. Use legal dictionaries if possible. Sometimes verbs are hard to find in legal dictionaries, so you may need to use a regular dictionary.</p> <p><i>Your 3 definitions should contrast one another or give extra information. They do not have to be long. After you have copied them from the internet, you can eliminate lines later. In the beginning, keep the whole internet address, so that you can access it as needed for comprehension (for example embedded words). <p>context Put your word in "bold" (<i>neretto</i>) within the context. <u>One</u> must be taken from the course book <i>Legal English and the Common Law & Legal Grammar Handbook</i>.</p> <p><i>Your examples do not have to be long, however, they should be long enough to illustrate their use in context. Your examples should be from an original legal document (a primary or secondary source). Do not include dictionary examples. SEE LIST of words that cannot be used! Try to avoid using Wikipedia. <p>related words (no reference) You should know what these words mean.</p>	<p>judicial decision, stare decisis, decided case, obligation, contract, agreement</p>
<p>collocation (no reference) You should know what these words mean.</p>	<p>binding – binding precedent, binding force, binding agreement, binding case, to be binding on, to be bound by</p>
<p>translation reference needed. Use <i>De Franchis</i> Bilingual legal dictionary.</p>	<p>binding – vincolare, obbligare <i>De Franchis Bilingual Legal Dictionary</i></p>

Other suggestions:

- You can eliminate the borders of the table on consignment to Prof. Riley.
