

1. STUDENTS ON TRANSFER CREDIT – All Transfer Credit students

Level of studies:

- <u>Undergraduate students</u>: Two years minimum of studies in business/social science, with at least a minimum equivalent of 60 ECTS credits in Business, ideally in the last year of their undergraduate programme with the equivalent of 120 ECTS credits in Business.
- <u>Postgraduate students</u>: Students must have obtained the level "Bachelor Degree" (BA, Licenciatura, etc.) or at least the equivalent of 180 ECTS credits in Business Studies.

Application deadlines	Fall semester \rightarrow 31 st May 2013. Spring semester \rightarrow 31 st October 2013.
Language requirements	The level of English is left up to evaluation of the home university (we ask the home institution to provide a certificate confirming the level of English is sufficient to take classes at ESC Rennes). All or most classes are conducted in English, therefore students are expected to have a sufficient command of the English language to be capable of understanding, making oral presentations, writing reports and exams etc. China requires students to have a minimum of 6 IELTS in order to obtain their visa (equivalent to TOEFL: IBT = 79, computer based = 213, paper based = 550, TOEIC = 750, IELTS = 6.5).
Application Procedure	 Fully completed application form signed by the candidate and the Home University. Official transcripts for the entire education of the student at the home university (translated into English if the transcripts are not in English, French, German, Spanish or Italian) with the official stamp of your home institution. CV (in English). Motivation letter (in English). A copy of the identity page of your passport. One passport photo attached to the application. An official certificate provided by your home institution certifying the level of your oral and written business English language skills (and French if electives taught in French are chosen).
