WENT than 6 MONTHS after the harassment has stopped or – writing a detailed petition to the Head of the Local Police		All precautionary measures and a restraining order from areas where you and your family usually go	Keep all useful information for the investigation like messages, phone records and any form of persecution. Never confront your stalker, call the emergency numbers 112/113 if s/he approaches areas where you live and work. If you are in the street go into the nearest shop. If in doubt go to the nearest police station.

If you are a woman victim of violence, pursuant to art. 2, D.I. 93/2013, the free legal aid service is guaranteed to you regardless of income.

If you are a worker, both in the public and private sectors, you can ask to be included in a protection path certified by social services in your municipality of residence and you are entitled to take a period of leave (or suspension of the relationship of work, in the case of coordinated and continuous collaboration) for a maximum of three months to participate. During this period of time you have the right to receive an indemnity and you can ask, when possible, your employer to transform your work relationship from full to partial, to allow you to participate continuously (Article 24, Legislative Decree. No. 80/2015).

If you are a public employee and you are included in one of the protection paths you also have the right to request a transfer to a different location by applying for transfer to another public administration located in a municipality other than the one where you reside, communicating it to your administration. If the administration indicated by you has vacancies corresponding to your professional qualification, your administration of belonging within fifteen days will dispose of your transfer (Article 30, paragraph 1-ter, Legislative Decree No. 165/2001).
