Open competition based on academic qualifications and examinations for the admission to the

Research Doctorate Courses - XXXVIII Cycle – Academic Year 2022/2023

DEADLINE for applications: 11 OCTOBER 2022 AT 11.59 (ITALIAN TIME - CEST)

Art. 1 Purposes of the announcement and general rules

An additional public competition is issued with reference to the announcement issued with Rector's Decree no. 928/2022 Prot no. 193786 dated 20 June 2022, based on academic qualifications and examinations for the admission to the following Research Doctorate Courses at the University of Ferrara – Cycle 38 – academic year 2022/2023.

Research Doctorate Courses have a duration of three years, starting 1st November 2022.

Research topics, available positions, admission requirements, methods and criteria for selecting and evaluating candidates in order to make the rankings are indicated in the attached sheets which are an integral part of this announcement.

The available positions will be assigned according to the merit rankings referred to in art. 9 of this announcement.

Candidates with a qualification obtained abroad compete for the places announced on an equal footing with other candidates.

The admission test calendar will be available at the web page:

http://www.unife.it/studenti/dottorato/concorsi/commissioni, after each PhD Course Boards of Professors will define them by the deadline of the present announcement, and promptly published.

The number of positions referred to in this announcement may increase following further available funding, either from public research bodies or from qualified private institutions, without prejudice to the deadlines for submitting the admission application form.

Should it occur a failure to complete the agreements with external institutions for the financing of scholarships and/or equivalent forms of research support, this will reduce the total number of ordinary places, even if they are indicated in the present announcement.

This announcement has the value of a notification in all respects.

Failure to comply with the rules contained in this announcement will result in exclusion from the competition.

This announcement is drawn up in Italian and English in compliance with the provisions of current regulations on the matter, and with the Ferrara University Regulations.

Art. 2 Positions deriving from DD.MM. 351/2022 and 352/2022

A) The Italian Ministry for University and Research, issued the Ministerial Decree (D.M.) 351/2022 and assigned to universities resources based on the PNRR (Piano Nazionale di Ripresa e Resilienza – Natioanal Recovery and Resilience Plan), Mission 4, component 1 "Strengthening of the educational services: from nursery schools to universities" – Investment 3.4 "Advanced teaching and university skills" and Investment 4.1 "Extension of the number of research doctorates and innovative doctorates for public administration and cultural heritage".

The University of Ferrara selected the research projects to activate as part of the University doctoral courses accredited for the XXXVIII cycle.

These projects, pursuant the above-mentioned Ministerial Decree 351/2022, are:

a. consistent with the objectives and purposes of the (EU) Regulation 2021/241; with the general strategy and with the detailed Sheet of the PNRR component;

b. aimed at achieving results measured in reference to milestones and targets that may be assigned to the Investment, within the terms that are established by the Plan;

c. compliant with the "do not cause significant damage" (DNSH) principle, pursuant to art. 17 of the (EU) 2020/852 Regulation; and coherent with the technical guidelines prepared by the European Commission (European Commission communication 2021/C58/01);

d. suitable for addressing and bridging gender inequalities;

e. in support of the participation of women and young people, also in accordance with the provisions of the Decreto-Legge (Decree) 31 May 2021, n. 77 (so-called "Decreto Semplificazioni" – "Simplifications Decree"), that was modified by the law 29 July 2021, n. 108, related to the management of the PNRR – National Recovery and Resilience Plan.

The interventions that are the target of such initiatives must also:

a. cover disciplinary and thematic areas consistent with the needs of the country, as well as the regional territories affected by the program, in terms of highly qualified figures oriented to meet the innovation needs of the companies referred to in the PNRR;

b. provide for the implementation of the entire doctoral, training, research and evaluation path at the administrative and operational headquarters of the beneficiary University, without prejudice to the periods of study and research at the company and abroad. These periods at the company and abroad must be planned consistently with the training and research activities that are provided for at the site of the proposing body;

c. ensure that the PhD student can use qualified and specific operational and scientific facilities, that must be in accordance with the law, in order to develop the study and research activities, including (if relevant with the type of course) scientific labs, libraries, data-bases and so on;

d. provide for the implementation of didactic activities for linguistic and computer science improvement; for research management; for the knowledge of European and international research systems, for the enhancement of research results and intellectual property;

e. promote the enhancement of research results and guarantee the protection of intellectual property by ensuring open access to the research results and to the relevant data in the shortest time and with the least limitations, according to the "Open Science" and "FAIR Data" principles.

f. Ensure compliance with the PNRR horizontal principles (environmental sustainability; sustainable development; equal opportunities and non-discrimination; accessibility for disable persons).

B) Furthermore, the Italian Ministry for University and Research, with the D.M. (Ministerial Decree) 352/2022 assigned resources, based on the PNRR, Mission 4, component 2 "From Research to Business" – Investment 3.3 "Introduction of innovative PhD Programs that respond to the innovation needs of businesses and promote the recruitment of researchers by enterprises", for the activation of dedicated doctoral programs, with the contribution and involvement of businesses.

Obligations relating to doctoral programs funded under the DD.MM. 351/2022 and 352/2022

In addition to the obligations for doctoral students, that are in the Regulations about Research Doctorates, issued with Rector Decree (D.R.) Rep. No. 448/2022 of 25/03/2022, the winners of a scholarship associated with research projects relating to DD.MM. 351/2022 and 352/2022 undertake to:

- Present a report every six months indicating the time commitment (articulated in months at the company, in site at UNIFE and abroad) and a summary of the main activities the PhD Student carried out; the report must be written through the appropriate online platform and using the forms therein;
- Ensure compliance with the communication and information obligations, provided for by art. 34 of the EU Regulation 2021/241. All documents must have the European Union logo and must indicate that the Programme is funded under the PNRR Italian Plan, with explicit reference to the EU funding and to the NextGenerationEU programme. It is mandatory to provide adequate dissemination and promotion to the Programme, online, via web and through social media, as requested by the PNRR Communication Strategy;
- Comply with the "do not cause significant damage" (DNSH) principle, to the environment goals, pursuant to art. 17 of the (EU) 2020/852 Regulation.

Furthermore, they are obliged, **under penalty of revocation of the scholarship**, to:

- Carry out the PhD program consistently with the project admitted for funding, unless the Ministry of the University and Research grants the necessary authorization to the previous request;
- The spend a mandatory period of study and research abroad (minimum 6 months, maximum 18 months) before the end of the PhD Course;
- The spend a mandatory period of study and research in a company (minimum 6 months, maximum 12 months) before the end of the PhD Course, as provided by the rules for scholarships funded within what is provided in **DM 351/22**, referred to programs dedicated to digital and environmental transitions, to the Public Administration and to the cultural heritage;
- The spend a mandatory period of study and research in a company (minimum 6 months, maximum 12 months) before the end of the PhD Course, as provided by the rules for scholarships funded within what is provided in **DM 352/22**.

At the end of the competition process, candidates that will be recipients of the scholarships as per the paragraphs **A**) and **B**) of this article must proceed with the enrolment in the PhD Course, in accordance with the procedures and timing indicated in art. 12.

Subsequently, the Ministry of the University and Research (MUR) will verify the eligibility for support within the PNRR projects and ANVUR (National Agency for the University and Research System Evaluation) will verify that the project are consistent with the DM 351/22 or DM 352/22 requisites.

Once both evaluations are complete, MUR will communicate the allocation of the final funding that will be due to each University.

The actual activation of the indicated positions is subject to the positive evaluation of consistency and eligibility, in order to receive the ministerial funding.

Art. 3 Admission Requirements

Applicants, without any limitation of age nor citizenship, must hold one of the following qualifications before this announcement deadline:

a) An Italian degree known as "Laurea specialistica/magistrale" or a degree awarded prior to approval of Ministerial Decree D.M. n. 509 of 3 November 1999, updated with D.M. n. 270 of 22 October 2004, n. 270 as well as second level academic titles (second level Masters) or their equivalent;

b) An equivalent foreign academic qualification awarded abroad considered equivalent to the titles on the fields as per letter a).

c) An equivalent foreign academic qualification awarded abroad considered equivalent to the Italian degree in terms of duration, level and area of study, in the fields as per letter a) and evaluated as adequate to this announcement.

Candidates who will achieve the necessary requirements for accessing the doctorate within **November 1st 2022** are also accepted. Should this be the case, applicants must inform IUSS Office via e-mail at dottorato@unife.it by **November 1st 2022**, sending a declaration with the specifics of the degree and the degree achieved.

In the attached sheets, that are an integral part of this announcement, candidates find for each research doctorate course the titles that are requested in order to participate in the call and any further requirement.

All candidates are admitted to the selection procedure, subject to verification of the self-stated declarations, as per DPR no. 445/2000 and following amendments and integrations. The University can make such verifications about the truthfulness of the declarations at any time during the evaluation and selection procedure, and also after the doctorate courses began, and request the submission of original documents.

The University may, at any time and by order of the Rector, exclude candidates who do not meet the admission requirements from the selection process.

Those already enrolled on the same doctoral Course cannot apply for admission.

Art. 4 Degrees awarded by foreign Universities

The eligibility of a degree awarded by a foreign university will be decided by the Selection Committee for the sole purpose of the admission to the doctorate, in accordance with the relevant Italian Law and with the Law of the country in which the degree was awarded, and in accordance with international treaties and agreements regarding the proof of recognition of gualifications.

The submission of online applications automatically implies the recognition of the eligibility of the degree awarded abroad. Applicants should therefore attach to their application the following documents:

Certificate or transcript containing a full academic record of the candidate's career, including marks from a) all years. EU citizens may submit a self-declaration certifying the possession of an academic gualification, according to DPR n. 445/2000 and subsequent amendments and additions;

In case the aforementioned documents are not in Italian or English, the applicant must provide a translation b) under the responsibility of the candidate;

Any other document that could be useful to the Selection Committee for the evaluation of the candidate's c) degree. (Diploma Supplement, for candidates holding a degree awarded in an EU country, such as; "Dichiarazione di Valore in loco" (declaration of value), issued by the Italian Authorities in the Country in which the degree was awarded, for applicants holding a degree awarded in a NON EU country; etc.).

Art. 5

Domanda di ammissione alle selezioni

The application form for admission to the selection procedure, including all mandatory documentation, must de dawn up and sent, under penalty of exclusion, within 11 October 2022 - ore 11,59 (Italian time - CEST) using exclusively the appropriate online procedure, available at the following link: <u>https://pica.cineca.it/unife/</u>

Applicants can access the procedure for submitting the admission application also using SPID (Public Digital Identity System. This procedure is available only for applicants already living in Italy). You can do so by choosing the University of Ferrara from the page of the available federations.

The application is completed by entering the requested information and attaching the documents indicated in the reference form of the course applicants are interested in.

Files must be in pfd-Adobe format only: maximum size 30 Mb for each attachment.

Files must be named with a number, surname, name, file name. For example: 1 surname name curriculum.pdf. Should there be files with more pages, add a number at the end, i.e.: 1 surname name curriculum 2.pdf

The application must contain the candidate's personal data, the residence, phone number, e-mail address, and the citizenship.

For all legal purposes the application is to be considered as a self-certification, pursuant to articles no. 46 and 47 of the Italian Presidential Decree 445/2000 and subsequent amendments, for all the data contained in the application and in all the enclosed documents.

Candidates who intend to apply for the specific positions listed below **must select the relevant voice** and then select the type of position and/or the type of fellowship for specific research topics in their application:

- Positions reserved for company employees, who are engaged in highly qualified activities (intersectorial doctorates);
- Positions with high-apprenticeship contracts;
- Scholarships for a specific research topic. These topics are duly explained in the attached forms, which are an integral part of this announcement.

Candidates who request to compete for scholarships for a specific research topic are NOT precluded from applying to the ordinary scholarship positions.

Once the application has been completed and submitted, candidates will receive an email to confirm the submission process finished and they will receive an identification code, which is essential for any communication with CINECA and the IUSS Office.

It is the candidates' responsibility to verify the correct procedure conclusion. Complaints will not be accepted for any malfunctions of the computer system due to overloads near the deadline.

Applications that at **11.59 (Italian time - CEST) on 11 October 2022** are incomplete in the compilation and/or in the mandatory attachments will be excluded.

In no case, additions to the documentation will be accepted after the deadline for the call.

Candidates wishing to participate in the competition for more than one doctoral course must submit an application for each course and attach the required documentation for each application.

Candidates are invited to complete the application for participating in the competition well in advance of the deadline for participating in the competition.

Art. 6

Support for candidates with disabilities or with specific learning difficulties (SLD)

Candidates with disabilities and/or with Specific Learning Disorder (SLD) can report their needs, which will be taken into account in the organization of the test. These Candidates are required to fill-in the appropriate "Aids/Additional time" section, indicating the aids required for carrying out the tests, and they have to attach one or more admitted certifications, referred to in the following paragraph, in a .pdf format.

Admitted certifications

According to Law no. 104/1992 (and its eventual changes and additions) and Law no. 170/2010 (and its eventual changes and additions) applications will be admitted with at least one of the following certifications:

- Valid certificate of disability, issued by the competent medical commission pursuant to Law no. 295/1990;
- Valid certification of handicap, issued by the competent medical commission for the local Health Service, pursuant to Law no. 104/1992;
- SLD diagnoses issued by the National Health Service or by specialists accredited by the Region. Certifications must be issued no longer than 3 (three) years from the expiration date of the present call, or must be issued after the Candidate turned 18;
- Other certifications that the Italian law make equal to the above mentioned certifications.

Candidates must upload the certifications that **must be readable and complete in each and all pages.**

Once the Candidates complete the registration procedure for the enrollment in the selection, they have to open a ticket on SOS (<u>sos.unife.it</u>) - Settore Servizio Disabilità e DSA – and write the registration number they received for their procedure. The ticket must be open within the Call expiration date.

Candidates with disabilities or with SLD, who are resident in foreign countries

Candidates with disabilities and/or with SLD who are resident in foreign countries, who intend to use the aids or the compensatory measures, must submit – according to the above procedure – a certification to certify the disability or SLD issued in the country where they are resident. They must attach a sworn translation of the certificate in Italian or English.

Evaluation of requests and granting of aids or compensatory measures for Candidates with disabilities or with LSD

The requests by Candidates with disabilities and/or SLD will be accepted with reserve and will be evaluated by the Coordination of Inclusion Policies – Disability and SLD Service – after hearing the possible opinion of experts in the field of disabilities and SLD.

It will be the responsibility of the Disability and SLD Service to communicate to the Candidates which aids or compensatory measures will actually be granted.

The University reserves the right not to provide aids or compensatory measures if the presented medical documentation is expired, unsuitable or received after the enrollment deadline.

Art. 7 Admission procedure

Selection procedures are shown in each enclosed description sheet, which form an integral part of this announcement and are published on the following web page: http://www.unife.it/studenti/dottorato/concorsi/ordinario.

The evaluation of qualifications and the interviews will be held within **19 October 2022**.

The timetable regarding the selection procedure is the official notification. **Candidates will not receive any** personal notice about the selection procedures.

Applicants do not have to attend the meetings regarding the evaluation of qualifications.

The evaluation committee has a total of 80 points at its disposal.

Evaluation criteria, including the minimum requirements for admittance to the interview, are outlined in each description sheet.

Oral tests can be carried out in a language other than Italian, only and exclusively if established in the informationform related to the chosen doctoral course.

In order to be admitted to the research doctorate course, the applicant must obtain a final score of at least 60 points. The final score is the sum of the points given during the assessment of qualifications and the interview. In the case of scholarships concerning a specific research topic, the examiners will evaluate the suitability of the candidate to enter the doctoral course, together with the suitability of the candidate for the specific research theme.

Art. 8 Selection Commission

The Selection Commission is appointed by the Rector and is composed in accordance with the provisions of art. 16 of the Regulations of Research Doctorates of the University of Ferrara, issued pursuant the Ministerial Decree 14 December 2021, n. 226.

The Judging Commission will not send any personal communication to the candidates regarding the outcome of the competition procedure: it is the sole responsibility of the candidates to inform themselves as described in art. 7 and 10 of the present announcement.

Art. 9 Ranking list

Publication of the ranking list will be the only official means of communication of the results, therefore **NO PERSONAL COMMUNICATION WILL BE SENT TO ADMITTED CANDIDATES.**

Art. 10 Course Admission

Candidates are admitted to the Doctoral Course after the approval of the selection proceedings, according to the order of the respective ranking list, until the number of positions included in the competition announcement is completed.

Admission to places covered by a scholarship or equivalent form of funding for specific topics, admission will take place according to the order of the ranking, with respect to the ascertained suitability for carrying out the research object of the funding.

Failure to complete the enrollment entails forfeiture of the right to be admitted to the Course. In this case, the vacant positions are assigned to those who hold a useful position in the merit ranking.

In the event of equal marks, other criteria will be taken into consideration and applied:

- for positions covered by scholarships evaluation of economic income prevails (refer to the Italian procedure called ISEE);
- For positions not covered by scholarships the youngest candidate will prevail.

For the reserved positions, the examination Committee will make a separate ranking list, depending on the types of reserved positions.

If a candidate is successfully included in different ranking lists, he/she must choose only one Doctoral Course.

In the case of withdrawal within a month of the beginning of the first year, this position becomes vacant and will be assigned to those applicants who have a place in the ranking list considering, if necessary, the specific field of research associated with the scholarship.

Admission to all positions with a scholarship or equivalent funding deriving from departmental funds and / or funds made available by external entities is conditional on, and subject to, the audits following the formalization of the financing.

Art. 11 Course Enrollment

Winning candidates must enrol via online procedure, following the enrolment instructions for winning candidates that will be available on the web page:

The deadline for enrolments is set mandatorily *on October 24th, 2022 – h. 11.30 a.m. (Italian time - CEST).*

No other enrolment method other than the one indicated will be accepted.

The enrolment application will be considered completed only after submission of all the documents listed in the enrolment guide.

Those who do not regularize their position within the deadline will be considered RENOUNCERS to all intents and the vacant positions will be assigned to other candidates, according to the order of ranking.

Art. 12 Replacements

Eligible Candidates that are not winners may state their interest in covering any places that may not be taken by winner candidates by filling-in the **REPLACEMENT FORM** and sending it via email to <u>dottorato@unife.it</u>, within **October 24th, 2022**, **h. 11.30** (Italian time - CEST). Those who do not comply with the replacement procedure will not be admitted to the reserved list.

Anyone entitled to take over will receive appropriate communication regarding the possibility and terms of enrollment by the IUSS Office.

Scholarships

Excluding what may be specified by particular agreements for Ph.D students' internationalization the annual gross amount of the University of Ferrara scholarship is € 16.243,00 and is subject to National Social Security contributions. Fiscal matters regarding scholarships are regulated by art. 4 Law 13th August 1984, n. 476.

The amount of the scholarship is increased by 50% for any period abroad up to a maximum of 12 months. This period is extended up to a maximum of 18 months for doctorate Courses that are co-supervised with foreign Insitutions or activated under the Universities regulatory framework on courses accreditation.

The payment of the scholarship is monthly-delayed instalments.

Scholarships are granted annually and may be renewed every year for the entire duration of the Course as long as the Ph.D. student passes the annual test, which is assessed by the Academic Board, according to art. 19 of the regulations about Ph.D. of the University of Ferrara, and according to the internal regulations of each course.

In case of withdrawal or decadence within a month of the start of the courses, the Ph.D student has no right to the first instalment of his/her scholarship, nor to any other form of funding.

The scholarship cannot be combined with any other scholarship, research fellowship or any equivalent funding, except those envisaged to supplement the scholarship for the training and research activities of the doctorate student at Unife and abroad.

Anyone who already benefited from a scholarship for a doctorate program, even if only partially, cannot apply for a fellowship a second time.

In the case of scholarships not awarded to competition winners, the same will be awarded to eligible candidates according to the order of the relative ranking.

Please refer to Chapter V (Rights and duties of doctoral students) of the University Regulations for PhD programs for further provisions on the subject

Art. 14 Enrolment Fees

Candidates holding a Scholarship:

Candidates enrolled in Research Doctorate Courses <u>holding a Scholarship</u> or any other kind of financial support – such as those enrolled in the Ph.D. Course with Industrial Doctorate, Salary Keep or High Apprenticeship programmes - must pay the tuition fees outlined in the table below:

Candidates without a Scholarship:

According to the Law no. 232/2016, candidates enrolled to a Research Doctorate course who do not benefit from a Scholarship are exempted from fees and contributions to the University. Therefore, candidates must pay only the fixed tuition fees:
